- Above fees structure is as per Adhoc Fees declared by FRA for AY 2025-26. It may be increase in future as per final fees fixation. If a final fee increases then student is supposed to tender arrears if any and vice versa.
- As per policy decision by GoM, no scholarship is available for Lateral entry in MBA for direct second year admission.
- Above fees is subject to fulfilment of eligibility criteria as per respective scholarship department. If any category student does not meet scholarship eligibility criteria, then such student is supposed to charge and pay fees as per fees decided for OPEN / Management students.
- It is sole responsibility of the student to fill and submit their scholarship reimbursement form on MahaDBT portal of GoM. Students are also supposed to submit hardcopy of scholarship form along with all necessary documents to institute ASAP.
- As per policy decision by GoM, the student could get only one kind of scholarship through-out his academic period. If in future it is found that, student have availed more than one scholarship, then he should return another scholarship to respective department. Legal prosecution may be attracted against default students and their parents as per government rule.
