1. The institution must have affiliation from the affiliating body for the above courses before making admission. In the absence of such affiliation, this letter of approval shall be treated as withdrawn.
2. The institution must appoint principal and other Full Time Faculty members including Technical & Non Technical staff as per AICTE Norms with pay scales as prescribed by AICTE, before making any admissions. The details are to be submitted in Western Regional Office, All India Council for Technical Education, Mumbai.
3. The Institution has also to submit a Registered Undertaking on Non-Judicial stamp paper of Rs.100/-, stating that exclusive built-up area has been created (furnish full details of **Instructional Area, Administrative Area and Circulation & other Amenities etc. in sq.m.**) to conduct the Diploma Engineering programme and the facilities created so are not shared with the Degree Engineering programme or any other programme. The undertaking must reach to this office within 15 days of dispatch of this approval letter, along with the photographs of Diploma Institution, as well as of degree institutions (if any) affixing the seal of the institution and the Principal, in support of such claim.
4. All the required Laboratories/ Workshops/ Machineries/ Equipments must be under operational conditions before making admissions.
5. No excess admission shall be made by the Institution during the academic year.
6. The approved course(s) shall commence as per the academic calendar of the Affiliating Body.
7. The approval is valid only for **Two (2) years**.
8. Name of the Institution, Name of the Society/ Trust, are not allowed to be changed without prior approval of AICTE. The name and title of the Institution should be such that "the Emblems and Names (Prevention of Improper use) Act 12 ("1950" of Government of India) is not violated in any manner.
9. In exercise of power conferred under 10 (p) of the AICTE, Act, AICTE may inspect the Institution any time it may deem fit to verify the progress / compliance or for any other purpose.
10. Any other condition(s) as may be specified by AICTE from time to time.


11. Consequent to the Supreme Court Judgement the Model constitution of Governing Body as notified by AICTE in it's approval Regulations 1994, stands overruled. "It has been Decided that while AICTE will not insist of any nomination in the Governing Body of Private unaided institutions, the Affiliating body/ state Government Shall impose minimum condition of affiliation, such as prescription of qualification of Government Body Members, in order to ensure academic excellence. The condition so imposed will be subject to scrutiny by AICTE, Wherever necessary, to ensure that the same are not unreasonable restrictions".

12. "It shall be desirable for the private unaided institutions to induct at 50% of members of the Governing body drawn from renowned academic , academic administrators, subject field experts and 4 professionals from industry in order to seek their innovative ideas for Continuous improvement in the delivery of teaching, learning process, making best practice elsewhere and achieve excellences".

In the event of infringement/ contravention or non- compliance of the above conditions and /or the provision of AICTE Act & Regulations/ Guidelines / Norms & Standards as prescribed by AICTE, further actions leading to "Reduced Intake" or "No Admission" or "Withdrawal of Approval", may be taken by AICTE and the liability arising out of such actions will be solely that of the Management of the Institution.

The Council reserves the rights to visit the Institution any time it may deem fit to verify the compliance of norms and standards of AICTE.
